

Breakdown of Taxes in Adult-Use States

States have taken a variety of approaches to legalizing, regulating, and taxing cannabis — including the method and rate of taxation. On the high end of the tax burden are Alaska and Washington state. In Washington, the total tax on retail sales can be as high as 47.4% with local taxes factored in. Meanwhile, Alaska imposes a \$50/ounce tax on cultivation, meaning the effective tax rate goes up as prices drop. If prices drop to \$100/ounce at retail, it would amount to an effective tax burden of 50%. Some states, including California, have decreased their tax burden as legal businesses found it difficult to compete with illicit, unregulated sales.

Newer legalization states are increasingly focusing on displacing the illicit market and are typically imposing lower tax burdens at the point of retail sales, while exempting medical cannabis. In Delaware, Maryland, Minnesota, and Ohio, which all passed in 2023 — taxes are imposed at retail and range from 9% total in Maryland to 16% total in Ohio.
