It omits or vastly undercounts patients in several states, including the most populous state, California, that don't either have mandatory patient registries or track the number of patients making purchases in the prior month.

- FN1 The patient registry is not yet open as of December 2024.
- FN 2 Also has adult-use legalization.
- FN 3 Does not have a patient registry.
- FN 4 Patient registry is partial, figure is a small percent of total patients.
- FN 5 Figures are for total patients making purchases in the prior month.
- FN 6 This is a significant undercount because some states do not have mandatory registries.
