

# Conservative Leaders and Marijuana Policy Reform

From the late William F. Buckley to President Donald Trump, prominent conservative leaders have recognized that outdated marijuana laws do more harm than good.

Several red states have legalized cannabis for adults, and most allow medical cannabis. Voters in seven states that Pres. Trump won in 2024 legalized cannabis for adults 21 and older in previous elections — Alaska, Arizona, Michigan, Missouri, Montana, Nevada, and Ohio. In Florida, a majority of voters approved legalization in 2024, but the vote didn't cross the 60% threshold needed to become law.

Meanwhile, 40 states have legalized medical cannabis, including deep red states like Alabama, Mississippi, Texas, Utah, West Virginia, and South and North Dakota. In late 2025, Pres. Trump ordered cannabis to be rescheduled to Schedule III, noting, “It will help many ... patients live a far better life.”

Conservatives are increasingly recognizing that cannabis prohibition infringes on our constitutional rights, burdens law enforcement, and makes public health regulations impossible. It also deprives veterans, older Americans, and individuals with medical conditions of the relief cannabis can provide.

## The Federal Government Should Respect States' Rights to Enact Cannabis Policies

### U.S. Sen. Ted Cruz (R-TX):

“I have long believed that the regulation of hemp and marijuana products should rest with each individual state. Reasonable minds can disagree, and a blanket federal prohibition disempowers the voters in each of the fifty States.”  
“A one-size-fits-all federal standard will undoubtedly create unintended consequences that harm consumers.”

### U.S. Senator Mike Lee (R-UT):

“I think it would always have made more sense for a thing like marijuana to have been regulated at a state level because this is a commodity that can be grown, harvested, packaged, sold and consumed entirely intrastate. And I think it probably would have made more sense to give the states the authority at the outset to make that decision on their own.”

**Americans for Prosperity Foundation:** “Under our system of federalism, the federal government only has limited, enumerated powers and does not have a general police power. By contrast, under the Constitution most government power is supposed to rest with the States, which did not surrender their general power of governing in that document, as the Tenth Amendment makes clear. Under this federalist system, most government decisions are supposed to be made at the state and local levels, reflecting the needs and priorities of their communities and allowing for state- and local-level innovation.”
