

Hawaii Cannabis Policy Voter Guide

Tuesday, November 8, 2022 is Election Day. You might recall that the Hawaii state Senate passed a legalization bill by a significant majority in 2021. However, the measure failed to gain traction in the House and died in this year's legislative session. This year's elections will be critical in determining whether Hawaii will finally adopt cannabis legalization in 2023.

We've put together a voter guide on where the candidates for stand on cannabis legalization. It includes responses to our candidate questionnaire along with information on whether incumbents supported cannabis bills in their past votes.

At the Hawaii Legislature all 25 Senate seats and 51 House seats are up this year due to reapportionment, which redraws district lines every 10 years based on the latest Census data. Your legislative districts may have changed since you last voted. Three state senators and seven House candidates have no general election opposition.

You can details for early voting and the steps and deadline to request an absentee ballot on the state Office of Elections website. The elections office says ballots for the general election are expected to begin arriving in the mail by Oct. 21. If you missed the Oct. 21 deadline to register for the election, you can still walk in and register before and on Election Day (with proper ID or documentation of your residency) at Voter Service Centers, which will be open Oct. 25 through Nov. 8.

Due to redistricting, your legislative district may have changed since you last voted. You can find your state Senate and House district — along with everything else that will be on your ballot — on Ballotpedia.

Here are the questions asked in the candidate questionnaire:

- 1.) Nineteen states including every state along the western seaboard and Nevada have passed laws making cannabis possession legal for adults. Would support legislation making cannabis legal for adults 21 and older to possess cannabis for personal use in the 2023 session?
- 2.) Do you support legalizing and regulating retail sales of cannabis and cannabis-infused products to adults 21 and older to create jobs and revenue for Hawaii?
- 3.) Most of the legalization jurisdictions allow adults 21 and older to discreetly and securely cultivate their own limited supply of cannabis for personal use, much as every state allows the home brewing of beer. Do you support allowing adults to grow their own cannabis for personal use?

- 4.) If Hawaii legalizes possession and retail sales of cannabis to adults 21 and older, would you support measures in the cannabis market to prioritize and incentivize opportunities for native Hawaiians and the communities most impacted by cannabis prohibition?

Governor

Josh Green (D) responded "Yes" to all four of MPP's survey questions - expressing support for legalizing cannabis for adults 21 and over to create jobs and revenue for Hawaii, allowing adults over the age of 21 to grow their own cannabis and prioritizing opportunities for native Hawaiians and communities most impacted by cannabis prohibition in the cannabis market. Also commented: "I support legalization, provided that the tax revenue generated from cannabis sales be used to help treat drug addiction and individuals suffering with behavioral or mental illness. "

Duke Aiona (R) did not respond to MPP's candidate survey. In September, the *Honolulu Star-Advertiser* [reported](#) he opposes legalization.
