S.C. Medical Cannabis Voter Guide Primary Election — Tuesday, June 14, 2022 State House of Representatives

Tuesday, June 14 is Primary Election Day for the South Carolina House of Representatives and <u>several other races</u>. <u>Early voting has already begun</u>. This year's election will be critical for determining whether South Carolina will finally enact a compassionate medical cannabis law in 2023.

We've put together a voter guide on where S.C. House of Representative primary candidates stand on medical cannabis. It includes responses to Sensible South's candidate questionnaire, along with information on whether incumbents cosponsored medical cannabis bills and their past votes.

If you're a registered voter, you can look up your state legislative districts and precinct location <u>here</u>. (After you fill in your information, the second section will be your Voting Districts. The relevant district for this primary is "SC House District.")

You can vote in either party's primary during early voting or on Tuesday, June 14: South Carolina does not have registration by party. (Only the Democrat and Republican parties have competitive primaries on June 14.)

If your district is not listed below, there is not a competitive primary. Check back for our voter guide leading up to the general election.

State legislative races have been so close some have tied. Don't miss out on this chance to determine who represents you in Columbia. You may also wish to volunteer for or contribute to candidates you are enthusiastic about.

Here are the questions asked in the Sensible South candidate questionnaire:

- 1) Would you support a narrowly crafted bill (similar to S. 150) to allow South Carolinians with serious illnesses to use and safely access medical cannabis if their physician has recommended that course of treatment?
- 2) If you are elected, would you work to ensure a medical cannabis bill gets a House floor vote on its merits in 2023?
