

# S.C. Medical Cannabis Voter Guide

## General Election — Tuesday, November 8, 2022

### State House of Representatives

Tuesday, November 8 is Election Day for the South Carolina House of Representatives and several other races. The election will be critical for determining whether South Carolina will finally enact a compassionate medical cannabis law in 2023.

We've put together a voter guide that shows where S.C. House of Representative candidates stand on medical cannabis. It includes responses to Sensible South's candidate questionnaire, along with information on whether incumbents cosponsored medical cannabis bills and their past votes.

If you're a registered voter, you may find your state legislative districts and precinct location [with the South Carolina Elections Commission](#). After you complete your information, the second section will be your Voting Districts. The relevant district for this primary is "SC House District." If you qualify to vote, but are not yet registered, you [can register online, by mail, or in person](#) 30 days before Election Day. The [SC Secretary of State's website](#) has more information about who can register to vote and how.

State legislative races have been so close some have tied. Don't miss out on this chance to determine who represents you in Columbia. You may also wish to volunteer for or contribute to the candidates of your choice.
