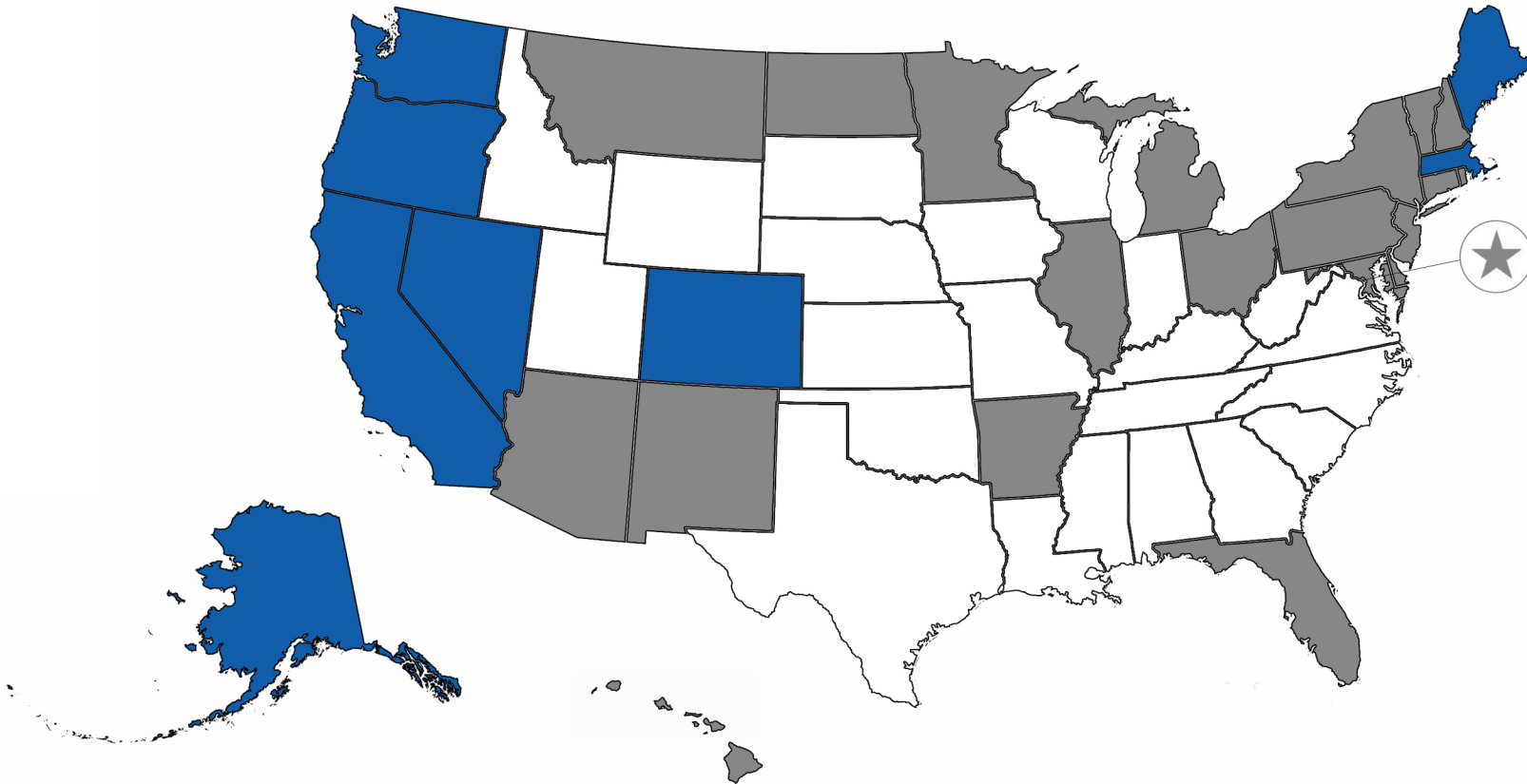


There was a sign this would happen...

# The Cole Memo 8/29/13

The August 29, 2013 memo (guidance) outlines eight priorities for federal prosecutors enforcing marijuana laws. Accordingly the DOJ will still prosecute individuals or entities to prevent:

- the distribution of marijuana to minors; **(KIDS)**
- revenue from the sale of marijuana from going to criminal enterprises, gangs and cartels; **(GANGS)**
- the diversion of marijuana from states where it is legal under state law in some form to other states; **(EXPORTING)**
- state-authorized marijuana activity from being used as a cover or pretext for the trafficking of other illegal drugs or other illegal activity; **(TRAFFICKING)**
- violence and the use of firearms in the cultivation and distribution of marijuana **(GUNS)**
- drugged driving and the exacerbation of other adverse public health consequences associated with marijuana use; **(DUI)**
- growing of marijuana on public lands and the attendant public safety and environmental dangers posed by marijuana production on public lands; **(PUBLIC)**
- preventing marijuana possession or use on federal property. **(FEDS)**
